ORAL QUESTIONS

1. By Hon. Betero Atanibora, MP (Abaiang)

OQ105. N na bubuti nakon te Minita n te botaki n reirei bwa bukin tera ngkai e wenanako ni karokoa ae e a namwakaina tabun aki bwakan aia mwane ataei ake a scholarship nako Fiji?

Rairana/Translation

I would like to ask the Hon. Minister of Education why scholarship students in Fiji are not receiving their stipend or allowance payments on time.

OQ106. N na bubuti nakon te Minita n te Lands bwa e na kabwarabwara bwa tera ae a kataia ni karaoia kain ana tabo ni mwakuri ae te Lands ngkai a rangi kakea bongan butiakia ibukin aia lease kain abau ae Abaiang ake I uoti araia nakoia?

I am requesting the Minister for Lands to provide a brief explanation regarding the actions of his officials, who seem to be disregarding the request made by the individuals from my constituency concerning their lease.

Upon our team's arrival in Fiji, we were informed that they would be relocating to apartments acquired by the Government. I kindly ask the Honorable Minister to take into account that, based on your Ministry's initial guidance, dialysis patients should remain at their current accommodations when determining future housing arrangements?

Is renovation work for Kieia Ataei Hospital remain on track as announced by the Minister in the last meeting of Parliament?

OQ113. E rikirake kabonganan Terikiai Tab-North bwa te tabo n roroo irouia kaibuke ni kawaia nakon ao n okia man te Itera Maiaki. E kona te Tautaeka ni katamaroa te rawa n rororake ao ni katea te Uabu ikekei?

Terikiai, Tab-North, is increasingly being used as port of call for ships going to and returning from the Southern Island. Could Government widen the boat passage and built a wharf there?
