#### ORAL QUESTIONS

##### 1. By Hon. Niiti Itaaka, MP (Arorae)

**OQ115.** Te roronrikirake bon ngaia kaubwain te abwamakoro n taai aika a na roko. E kona te Minita ke te Botaki ni Mwakuri are tabena n katea te multi-purpose court iaon Arorae n te aro bwa ana bane ataei n kona reiakinaki te naan sports n aekaia nako ao e na reke bwa aia program ni katoa bwakantaai. N te aro aei ao ana tabetabe n te takakaro ao man rabakauia naba n takakaro a na kona n roko i tinanikun Kiribati n ira te kaboo ke te kauaaba iaon aia tarena aika ana reiakinaki iai?

##### *Rairana/Translation*

Young people are an important resource and the island's future leaders. Could the Minister responsible consider the proposal to construct a multi-purpose court on Arorae, to involve the community, particularly the young people, and help cultivate a passion of sports that could help them be ready for future sporting events?

**OQ116.** E kona te Minita are tabena karaaoan te uruaki nakon te naan ice maker/plants ake a tia ni karokoaki nako aonnaba ni karekea te ibuobuoki ibukin kawaekoan katiaaia n te aro bwa e na kona ni manga karekea te kabwaia nakoia kain te aba n aron teuana ae mena iaon abau ae Arorae?

##### *Rairana/Translation*

Could the Minister liaise with the relevant unit in his department to ensure that repairs to the Arorae ice-maker/plants are carried out at the earliest opportunity, so it can be used again?

**OQ117.** I kona n titiraki nakon te Minita are tabena bwa e a bwaka iaa ngkai rongorongan te desalination machine are I uotiarake n te bowi ae e nako?

### **Rairana/Translation**

Could I kindly ask the Minister concerned to provide an update on the progress made regarding the need for a desalination plant, which I raised in the last parliamentary meeting?

**OQ118.** Te auti n Takataka iaon Arorae e a maan ni wene n akea te onobwai nakoiai. I kona n butia te Minita are e mena n te botaki n takataka iaona bwa e a karekea te ibuobuoki nakon te auti n takataka bwa aonga n mwengaraoi taan Katine ben iaon Arorae?

### **Rairana/Translation**

The copra shed on Arorae has been in disrepair for quite some time now. Could the Minister responsible kindly liaise with relevant authority in his department to consider undertaking repairs so that it can be used again?

## **2. By Hon. Banuera Berina, MP (Kuria)**

**OQ119.** E korakora kainnanoia kaain Kuria ibukin babaenikain ao taataren mwanen te takataka. I butia te Minita are tabena bwa e na kabwarabwara bwa bukin tera e a korakora ngkai te baenikai ni kaineti ma reereken aia mwane taan oroben?

There is a grave need by the people of Kuria because of the delay and the shortage of the copra funds. Could I ask the Minister concerned to explain why there is now a big delay in relation to the receipt of the copra funds by the copra cutters?

How has Cabinet decided to improve “te mwane ni kara?”

**OQ123.** Ni kaekaan au bubuti ni kan ongoraa rongorongon aia bubuti kaain St. Michael ao KUC Oneeke, ibukin aia livelihood grant ao I kaongoaki bwa a tabe moa ni mwakuriaki kabanemwane ibukin te ririki ae e nako.
