ORAL QUESTIONS

1. By Hon. Dr. Tinte Itinteang, MP (Betio)

OQ13. N na butia te Minita are tabena, ana ibuobuoki ibukin barongan taian konteina ake a tei irarikin aia tabo te botanaomata iaon Betio?

Rairana/Translation

Can I ask the Minister responsible for their assistance towards proper placement of shipping contains, especially those adjacent to public access in Betio?

OQ14. N na butia te Minita are tabena, ana ibuobuoki ibukin te katamaroa nakon taian feeder roads iaon Betio ake a tia n katamaroaki n te timanti ke te geo-cell?

Rairana/Translation

Can I ask the Minister responsible for their assistance towards upgrading works to feeder roads on Betio that have been upgraded with concrete or geo-cell.

OQ15. N na butia te Minita are tabena, bwa iai ana baronga n ana tabo n makuri ibukin katauraaoia ara botanaomata imwain nakoia n kaei aia mwakuri n tabo n kamwakuri itinaniku, n aron te kini uanikai i NZ?

OQ21. This matter was previously raised here during my first term in August 2020 and reiterated in August 2023. I respectfully request at this point in time since these machines are available for our causeway construction on Marakei, please?
