MOTIONS

1. **By Hon. Tauanei Marea, MP (Nikunau)**

Motion 7

Bwa te Maneaba aio e na nora riain kateakin ana komete te Maneaba ni Maungatabu ae e teimatoa ae e na tabe ma te reirei iaon Kiribati.

Rairana/Translation

That this Maneaba would view the need of establishing the Maneaba ni Maungatabu's standing committee for education in Kiribati.

Motion 8

Bwa te Maneaba aio e na butia te Tautaeka bwa e na karaoa te kamatebwai ibukin karaoan taian uaabu n aaba aika aki nama n aron Nikunau.

Rairana/Translation

That this Maneaba would request the Government to study and explore ways to build wharfs at islands without lagoons such as Nikunau.

Motion 9

Bwa te Maneaba aio e na butia te Tautaeka bwa e na kaunga ribanakin te aroka ae te kaina n aekaia nako iaon Kiribati ni kabutaa ibukin tamaroana ni bwain te auti ao uaana a rangi n bongana ibukin marurungin te rabwata.

Rairana/Translation

That this Maneaba would request the Government to support planting of various species of pandanus tree across Kiribati as they are essential for building local houses and their fruit has high-quality vitamins that are beneficial to health.

Motion 10

Bwa te Maneaba aei e na nora riaina bwa te nati ni Kiribati ake a koro 18 aia ririki ni waerake a na kabaeaki iaan te Tua bwa a na karaoa te rinerine ao man anganaki te tuua ngkana aki karaoa te rinerine.

Rairana/Translation

That this Maneaba kindly consider the implementation of compulsory voting throughout Kiribati for all citizens who have attained the age of 18 years and above, and ensure that appropriate measures are taken against those who fail to fulfill this significant obligation.

Motion 11

Rairana/Translation

The government is requested to consider if it will be able to assist its employees who still have not received allowances in performing frontline security and businesses who have also lost goods during transshipment from Tarawa to the Islands at the height of Covid 19.

Motion 12
