ORAL QUESTIONS

1. By Hon. Tebuai Uaai, MP (Tarawa Teinainano)

OQ17. N ana ka-4 ni Bowi te Maneaba aei ae Aokati n te ririki aei, 2025, ao I tabeka te “Bubuti-n-Nanoangaki”, bwa ni kaineti ma te Tua 25(6) n te Tua ni Kaetieti ibukin Bowin te Maneaba aei ao e na anganaki te Komete ae Onoti bwa e na karaoa ana kakae bwa e riai katean te Tarabunare ibukin Kaetan Abaia kaain Tarawa ke e aki. N na butia te Tautaeka bwa tera rongorongon tobwaan te “Bubuti-n-Nanoangaki” aei, taiaoka?

Rairana/Translation

During the 4th Sitting of this Maneaba in August this year 2025, I voiced a humble request that in accordance with Rule 25(6) of the Rules of Procedure of this Maneaba, the “Petition” shall be referred to a special Committee and the task of this Committee is to carry out an investigation on whether a Land Grievance Tribunal (LGT) for landowners on Tarawa should be established or not. I wish to request Government, what is the update regarding this humble “petition”, please?

I kindly ask the Minister concerned, to explain what the Government policies are, in related with the number of clinics for each respective islands in Kiribati?

In the second sitting of the Maneba ni Maungatabu, I raised a question to the Minister of Education, concerning a renovation needed to Schools classrooms and Maneaba. I kindly ask the Honourable Minister to provide any update on this please?

We all confirmed that water is essential to life, in other words, water is life. At this time a desalination plant at Tebikerai still continued not working so I kindly ask the Honourable Minister concerned to address this important issue?
